  - is engaged in the importation of prepared pet food into Australia; and
  - acts as the primary manufacturer's agent for prepared pet food; and
  - primarily markets a range of prepared pet food in Australia; or
  - is generally responsible for a prepared pet food range in Australia; and
- **Allied Industry Member** – an entity who provides goods or services in the pet food supply chain.
